# Placement Considerations

When installing your MS5E-18 Expansion SmartBox, there are four major placement considerations that will ensure you get the optimal performance and longevity out of your system.



## Safety

The SmartBox must be installed with screws onto wooden studs minimum size 2" x 4" (5cm x 10 cm) or concrete block minimum thickness 8" (20cm). Ensure the power outlet, environment and installation approach meets all requirements and standards in accordance with documentation available at [www.keycafe.com](http://www.keycafe.com) as well as local laws, regulations and guidelines related to fixed installations. Always install with 2 people to prevent dropping the SmartBox with cables attached.



## Security

Install in a well-lit, surveilled area to reduce the risk of theft or vandalism. The Keycafe SmartBox is a convenient way to manage key access and can be damaged or broken into if left unattended in unsecured areas.



## Accessibility

The installation area should consider all users of the SmartBox so they can reach all bins, the scanner and keypad, as well as continued accessibility of pathways and halls the SmartBox is installed into. We recommend at a minimum adhering to US ADA guidelines which recommend the max height of the top of the SmartBox to be 48" (122cm) from the floor and a minimum of 48" (75cm) of obstruction-free space in front, but you should also check any local regulations or guidelines that may be applicable to your installation. 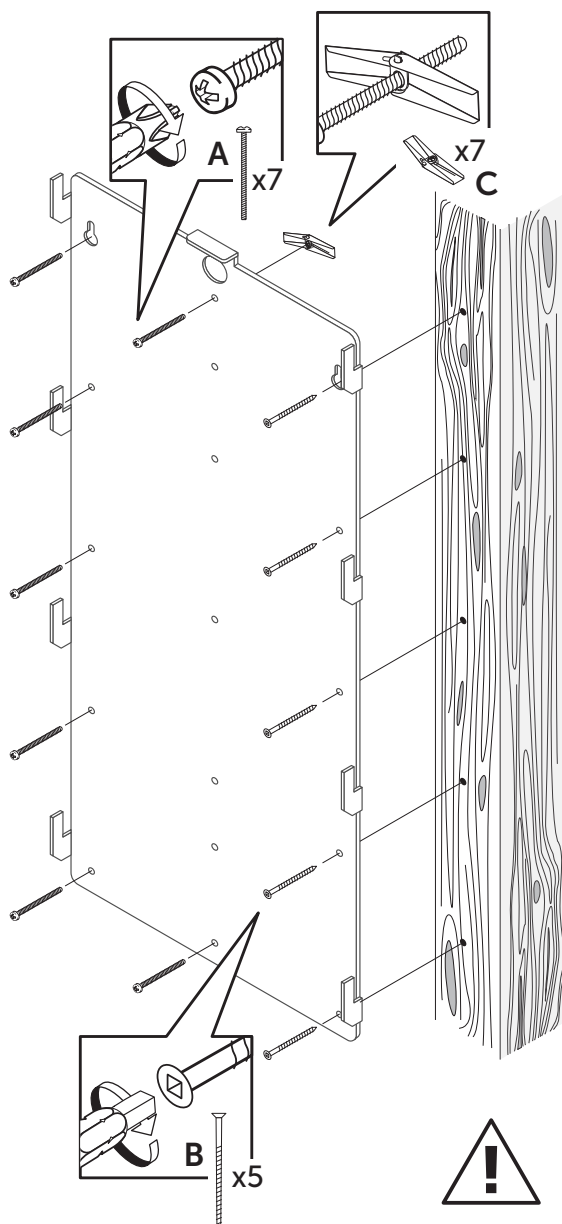


## Expandability

If you plan to purchase more expansion units in the future, keep in mind the space required for them. Each MS5E-18 requires a min of 11.4" x 23.3" (29cm x 59cm) area to install. Each MS5E-42 requires a min of 23.8" x 23.3" (60.5cm x 59cm). You can mount expansions on either side of the base station.

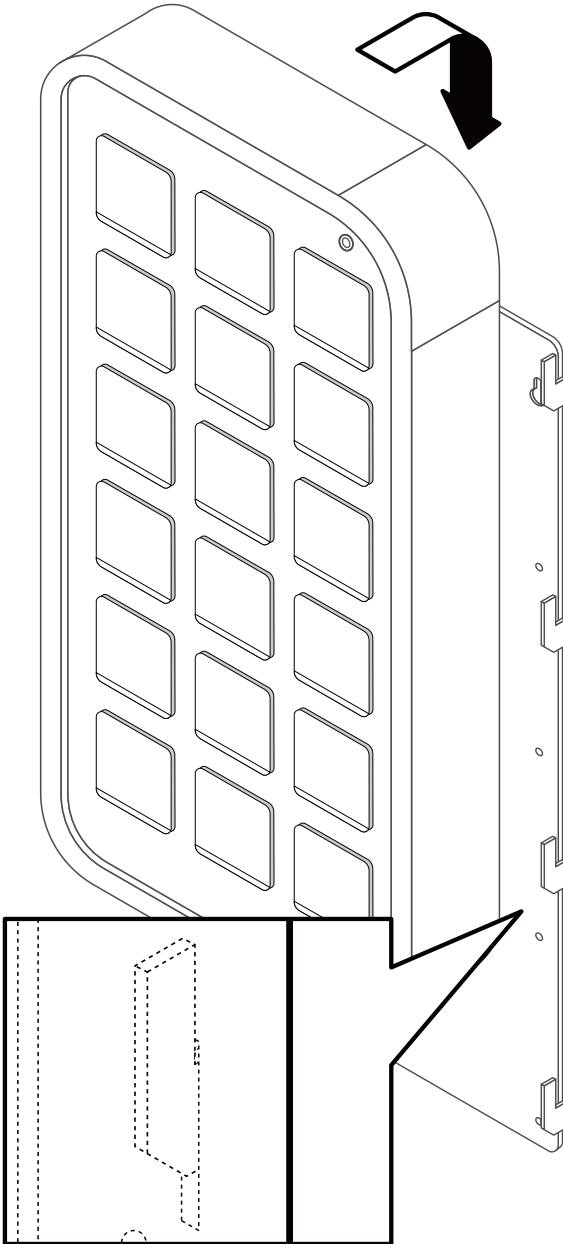

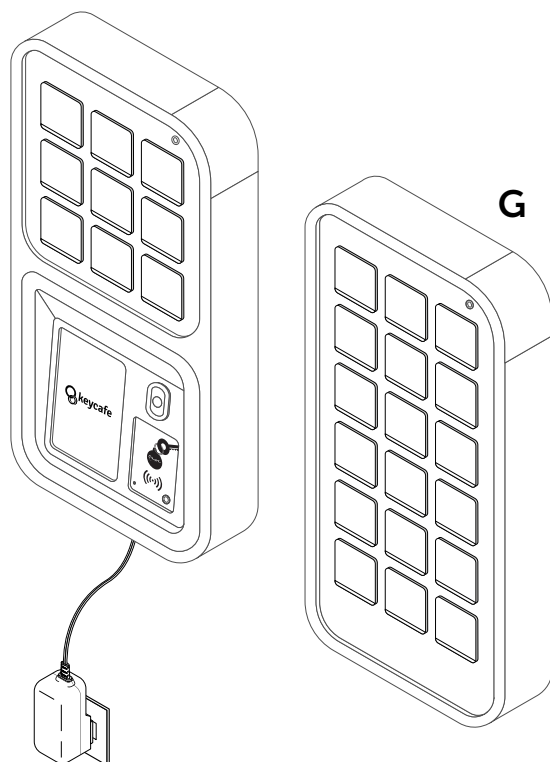

# Considérations relatives à l'emplacement

Lors de l'installation de votre SmartBox d'extension MS5E-18, il y a quatre considérations de placement majeures qui vous assureront d'obtenir les performances et la longévité optimales de votre système.



## Sécurité

La SmartBox doit être installée avec des vis sur des montants en bois de taille minimum 2" x 4" (5 cm x 10 cm) ou un bloc de béton d'une épaisseur minimum de 8" (20 cm). Assurez-vous que la prise de courant, l'environnement et l'approche d'installation répondent à toutes les exigences et normes conformément à la documentation disponible sur [www.keycafe.com](http://www.keycafe.com) ainsi qu'aux lois, réglementations et directives locales relatives aux installations fixes. Assurez-vous d'installer à 2 personnes pour éviter que la SmartBox tombe avec les câbles attachés.



## Sûreté

Installez dans un endroit bien éclairé et surveillé pour réduire les risques de vol ou de vandalisme. La SmartBox Keycafe est un moyen pratique de gérer l'accès aux clés et peut être endommagée ou cassée si elle est laissée sans surveillance dans des zones non sécurisées.



## Accessibilité

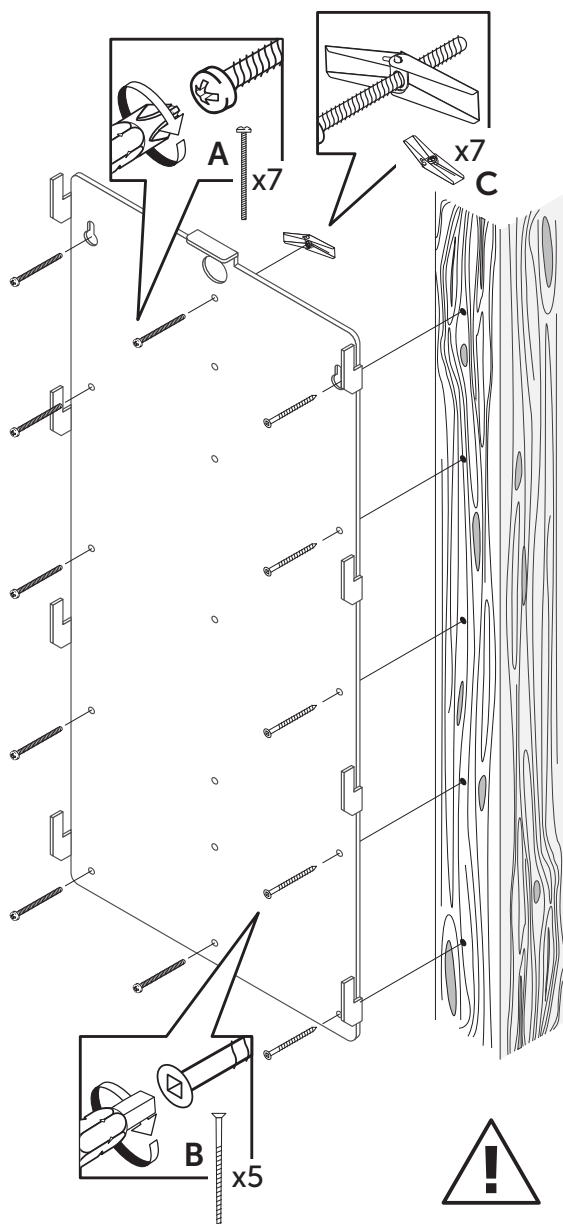
La zone d'installation doit tenir compte de tous les utilisateurs de la SmartBox afin qu'ils puissent atteindre tous les casiers, le scanner et le clavier, ainsi que l'accessibilité continue des chemins et des halls dans lesquels la SmartBox est installée. ## Extensibilité

Si vous avez acheté des unités d'extension ou prévoyez de le faire à l'avenir, gardez à l'esprit l'espace requis pour celles-ci. Chaque MS5E-18 nécessite une superficie minimale de 29cm x 59cm pour l'installer. Chaque MS5E-42 nécessite une superficie minimale de 60.5cm x 59cm pour l'installer. Vous pouvez monter des extensions de chaque côté de la station de base.

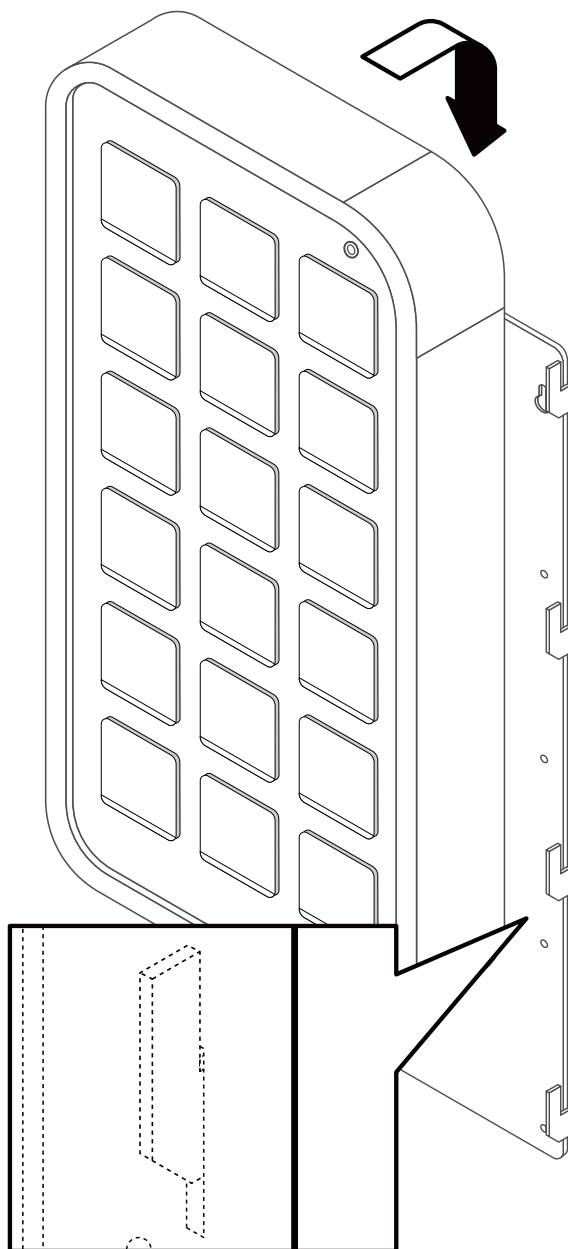

## 設置の注意点

拡張用端末 (MS5E-18) を設置する際には、以下4つの注意点を考慮してください



### 安全

SmartBoxは5cm x 10cm 以上の木製下地、または20cm以上の厚さのコンクリートにビス留めで設置してください。電源、その他設置環境・設置方法が、[www.keycafe.com](http://www.keycafe.com)に記載の必要条件と、設置場所における法律、条例に順することをご確認ください。設置の際にSmartBoxを落とさないよう、2名での作業をお勧めします。



### セキュリティ

盗難・破壊を避ける為、明るく、監視可能な場所に設置してください。Keycafeは利便性の高い鍵管理サービスですが、治安の悪い場所に放置されると壊される可能性もございます。



### アクセシビリティ

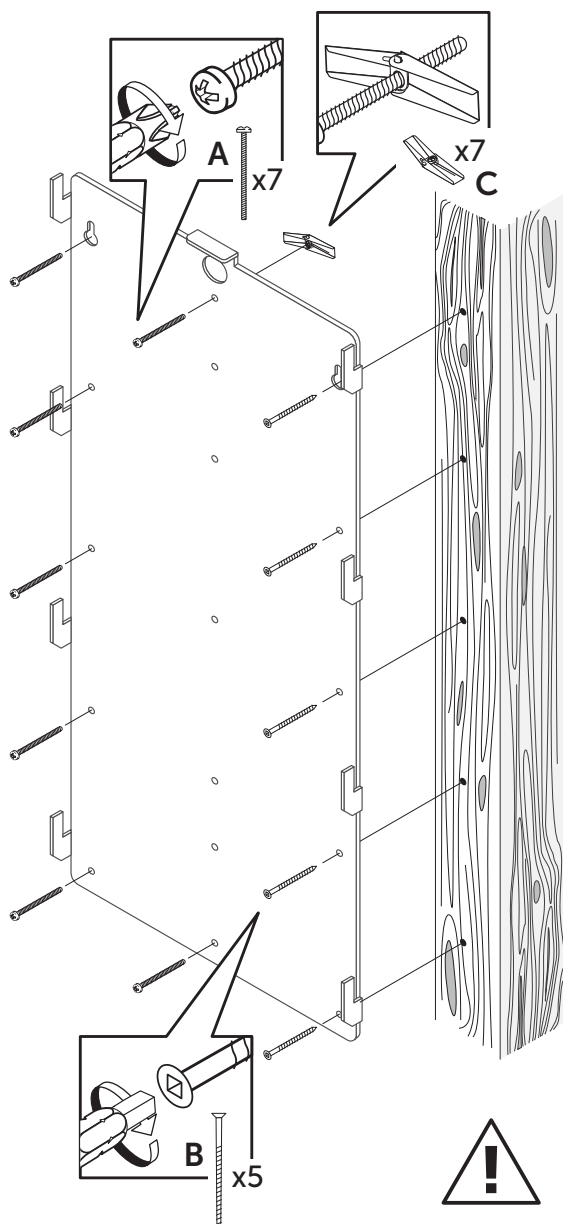
SmartBoxの全ての鍵キャビネット、スキャナとタッチパネルが利用できる環境に設置してください。鍵の受け渡しが必要な時間帯に、利用者がアクセスできることも必要です。Keycafeはアメリカ障害者法 (ADA) ガイドラインの遵守を奨励しています。SmartBoxの上部が地面から122cmまで、SmartBoxの前に最低限75cmの障害物の無いスペースを確保することが推奨されます。
